DISCUSSION ITEMS:

Mantooth Engagement:

Mantooth completed door to door meetings. Window clings were not included in that due to not being able to locate them. Door clings were found and now Jamie will be sending out a handwritten note with her card thanking rate payers. The clings will be included in that thank you letter.

Business Bond Program Update:

After Mantooth introduced the program, several businesses showed interest, however, due to complications and timing we feel it might be more appropriate to introduce more of a discounted gift card program. I.e., Buy a \$100 gift card to a local business for \$75. The business will still receive the full \$100. We will need to put a time frame/Cap on the program...like first come first serve until money runs out. Board likes this idea and just wants to make this as simple as possible for rate paying businesses. We should reach out to those rate payers that have been vocal about the BID as well as those that shown initial interest in the Bond program first. It was discussed that we should have a subcommittee to help guide this effort.

Website and Newsletter Update:

The website is awaiting final content and will be ready to launch in early May. Draft content for the newsletter was reviewed (as per the agenda) and approved. The board also discussed included a business of the month feature, and to start with Red Wing Shoes. ED Giellis will reach out to Bonnie at Red Wing Shoes to get information for the first newsletter, to launch in early May. ED Giellis also suggested we at least set up and minimally manage a Midtown Facebook page, and the board agreed. A FB account will be set up and populated before the next board meeting.
